COURSE DESCRIPTION

In this course students will apply quantitative, qualitative, and mixed mode methodologies to research design. Emphasis will be placed on collecting, analyzing, interpreting, and reporting data in research studies. Upon completion of this course, students will be able to outline the requirements for a research study and write a methods section of an article, dissertation, or grant proposal.

Peer Review #1

Students will provide feedback on a classmate's prospectus draft. Students will use Microsoft Word's Track Changes feature to complete in-text edits, as well as the Comments features to provide further feedback for consideration. Reviewers are to evaluate both the conceptual elements of the prospectus components, as well as the writing/APA in the document.

Midpoint Prospectus Draft

Students will submit their completed prospectus up to Week 6. It should include all components completed thus far (1-7) and be formatted in the CityU prospectus table, single-spaced, 12 pt, Times New Roman font. The prospectus draft should reflect the comments made by the instructor in prior reviews. If the components include in-text citations, the student needs to include a reference list at the bottom of the document in APA format.

Instructor Determined Assignments

Class participation through discussion activities is an integral part of this course. To provide structure for balanced participation and allow maximum benefit of enhanced discussion activities and learning, the following is required: (a) responses to discussion questions are posted within the first three (3) days of the online school week (the online school week starts on Monday 12:01 am and ends Sunday at 12:00 am PST.); (b) at least one scholarly resource cited in APA format supports the response; (c) at least three thoughtful and topic-relevant comments, questions, or research notes are posted in response to posts by classmates during the online school week; and (d) any questions the instructor posts regarding the original post are responded to by the end of the online school week.

COURSE POLICIES

Late Assignments

SAL students are required to submit all assignments by the due dates stated in the course schedule. A late assignment is one that is submitted after the due date or after any extension has expired.

If circumstances prevent a student from meeting the due date, the student needs to contact the instructor and request an extension at least 48 hours prior to the date the assignment is due. Emergency situations will be considered on a case-by-case basis.

Being busy, pressured with outside work, technical issues, or having competing academic commitments are not valid reasons to grant extensions. A student who receives an extension in advance of the due date and abides by the agreement with the instructor is not subject to late penalties. Without prior arrangement with the instructor, students who submit assignments late will receive a 5% deduction in grade each day or part of the day that the assignment is late up to a maximum of 25% off. Coursework received after 10 days will not be graded and will receive a zero grade, unless prior arrangements have been made.

Professional Writing

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.
