COURSE DESCRIPTION

This course will provide a general overview of nonprofit leadership including the role of boards; the management of volunteer staff; the basics of nonprofit marketing and fundraising; and the need for strategic planning in nonprofit leadership. Leadership theory will illustrate how the public and private sectors influence policy, planning, and organizational development in the nonprofit sector.

SPECIFICS OF COURSE ASSIGNMENTS

The instructor will provide grading rubrics that will provide more detail as to how this assignment will be graded.

Characteristics of Nonprofit Organizations

The paper will include: (a) an introduction; (b) a brief history of the nonprofit sector in the US (topic focus is on economic and social impacts); (c) a brief analysis of the various types of nonprofit organizations (i.e. social welfare, philanthropic, religious, etc.) that should include unique governance and/or structural features; (d) from this review, identify a single nonprofit organization and discuss the role of board members, volunteers, and other stakeholders; (e) within this organization, include challenges the nonprofit leader faces in leading and managing these groups; (f) a conclusion.

Students will write a 6-8 page paper (not including cover, abstract, and references), using APA style, 12-point double spaced Times New Roman font, and include a minimum of five (5) resources.

Nonprofit Leadership Interview

The paper will include: (a) an introduction that includes a brief examination of the organization's name, history, mission, programs, and key stakeholders; (b) an analysis of key challenges the subject faces in running a nonprofit with a focus on ethical leadership and specific areas the subject is especially proud of; (c) student evaluation on the subject's leadership contribution to the organization; (d) evaluation of the interview describing personal student leadership take-a-way(s); (e) a conclusion.

Students will write a 6 - 8 page paper (not including cover, abstract, and references), using APA style, 12-point double spaced Times New Roman font, and include a minimum of five (5) quality references. As portions of this paper pertain to personal reflection, the student has the option of writing in first-person (using pronouns: I, we, us, them, etc.) or third-person.

Nonprofit Leadership Framework

The paper will include: (a) an introduction to the topic; (b) an analysis of what makes an effective leader in a nonprofit organization; (c) using the content created in section b, students are to perform a personal leadership gap analysis (ie: identify personal strengths and weaknesses) to develop a personal nonprofit leadership framework; (d) from this gap analysis and from the student's journal writing, synthesize key personal leadership style, traits, and behaviors that would further the organization's leadership capacity in terms of ethical practice and at least two of the following topics: Employee development, strategic planning, philanthropy planning, financial management, and public relations; (e) a conclusion.

Students will write a 8 - 10 page paper (not including cover, abstract, and references), using APA style, 12-point double spaced Times New Roman font. The paper will synthesize material from the student's leadership journal, as well as learning from the previous course assignments. The paper will include a minimum of five (5) resources. As portions of this paper pertain to personal reflection, the student has the option of writing in first-person (using pronouns: I, we, us, them, etc.) or third-person, but do not switch back and forth.

Formative Assessments

Class participation through formative assessments is an integral part of this course. Formative assessments can be journals, papers, activities, quizzes, discussions, wikis, or other activities determined by the course manager and instructor. Each formative assessment includes its own rubric and/or due date as outlined within the activity to balance participation and enhance learning. Whether in class, online, or in a mixed mode setting, students will be graded on their ability to present, explain, or defend alternative viewpoints and the degree to which they have mastered the concepts and principles inherent in the study of leadership. Written work is assessed on relevance to the subject presented, adherence to writing mechanics and organization, and professional presentation.

COURSE POLICIES

Late Assignments

Students are required to submit all assignments by the due dates stated in the course schedule. A late assignment is one that is submitted after the due date or after any extension has expired.

If circumstances prevent a student from meeting the due date, the student needs to contact the instructor and request an extension at least 48 hours prior to the date the assignment is due. Emergency situations will be considered on a case-by-case basis.

Being busy, pressured with outside work, technical issues, or having competing academic commitments are not valid reasons to grant extensions. A student who receives an extension in advance of the due date and abides by the agreement with the instructor is not subject to late penalties.

Without prior arrangement with the instructor, students who submit assignments late will receive a 5% deduction in grade each day or part of the day that the assignment is late up to a maximum of 25% off. Coursework received after 10 days will not be graded and will receive a zero grade, unless prior arrangements have been made.

Professional Writing

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.

Participation

Participation is determined through your active engagement in classroom activities each week. This can be measured through your discussion board posts or by submitting an assignment when due.
