COURSE DESCRIPTION

This course explores the complexities of organizational design and how specific design features complement and enhance organizational decision-making, use of information, problem-solving, accountability, empowerment, and other elements of organizational behavior. Emphasis is placed on identifying the elements of organizational culture and the strategic application of organizational design to ensure alignment with desired behaviors and culture. Students will design an organization to support specific organization-wide behaviors and culture.

SPECIFICS OF COURSE ASSIGNMENTS

The instructor will provide grading rubrics that will provide more detail as to how this assignment will be graded.

Organizational Design and Culture Evaluation Paper

Students will identify the organizational design of a familiar organization and evaluate the design's impact on the organization's culture.

The paper will include (a) a description of the organization's design; (b) a description of the organization's culture; (c) an evidence-based evaluation and discussion of the aspects of the organization's design that contributes to the organization's culture; (d) conclusion.

The paper should be 6-8 pages (2100-2800 words), double-spaced, in 12pt Times New Roman font, and follow APA writing conventions. Students must integrate a minimum of ten (10) peer-reviewed, scholarly resources (including 3 new resources not previously used in the student's Discussion Activity posts).

Organizational Design Recommendations

Building on the Organizational Design and Cultural Evaluation Paper, students will develop recommendations (with research and evidence support) to apply elements of organizational design to strategically align with desired culture and organization-wide behaviors.

The paper should include (a) a discussion of which elements of organizational design currently align with desired culture and organization-wide behaviors; (b) a discussion on which components of the design do not strategically align with desired culture and organization-wide behaviors; (c) research and evidence-based recommendations on implementing changes to elements of organizational design to ensure that these elements strategically align with desired culture and organization-wide behaviors; and (d) a conclusion.

Students must critically evaluate and integrate a minimum of ten (10) peer-reviewed, scholarly resources (including 3 new resources not previously used in the student's Discussion Activity posts). The paper should be 8-10 pages (2800-3500 words) double-spaced, in 12pt Times New Roman font, and follow APA writing conventions.

Leadership Competencies for Organizational Design

Students will critically evaluate leadership competencies essential for future leaders who lead organizational design efforts and elements of life-long learning.

The paper will include: (a) introduction; (b) a discussion of a minimum of four (4) leadership competencies essential for future leaders of organizational design efforts (6-8 pages); (c) a discussion of lifelong learning as outlined in the grade rubric (1-2 pages); and (d) conclusion

The paper is to be 7 to 10 pages (2450 to 3500 words) not counting title page or references and adhere to APA writing conventions, Times New Roman 12pt. font, and a minimum of ten (10)

academic, peer-reviewed resources.

Formative Assessments

Class participation through formative assessments is an integral part of this course. Formative assessments can be journals, papers, activities, quizzes, discussions, wikis, or other activities determined by the course manager and instructor. Each formative assessment includes its own rubric and/or due date as outlined within the activity to balance participation and enhance learning. Whether in class, online, or in a mixed mode setting, students will be graded on their ability to present, explain, or defend alternative viewpoints and the degree to which they have mastered the concepts and principles inherent in the study of leadership. Written work is assessed on relevance to the subject presented, adherence to writing mechanics and organization, and professional presentation.

COURSE POLICIES

Late Assignments

Students are required to submit all assignments by the due dates stated in the course schedule. A late assignment is one that is submitted after the due date or after any extension has expired.

If circumstances prevent a student from meeting the due date, the student needs to contact the instructor and request an extension at least 48 hours prior to the date the assignment is due. Emergency situations will be considered on a case-by-case basis.

Being busy, pressured with outside work, technical issues, or having competing academic commitments are not valid reasons to grant extensions. A student who receives an extension in advance of the due date and abides by the agreement with the instructor is not subject to late penalties.

Without prior arrangement with the instructor, students who submit assignments late will receive a 5% deduction in grade each day or part of the day that the assignment is late up to a maximum of 25% off. Coursework received after 10 days will not be graded and will receive a zero grade, unless prior arrangements have been made.

Professional Writing

Assignments require error-free writing that uses standard English conventions and logical flow of organization to address topics clearly, completely, and concisely. CityU requires the use of APA style.

Participation

Participation is determined through your active engagement in classroom activities each week. This can be measured through your discussion board posts or by submitting an assignment when due.
