Course Description

This course is intended to provide students with support as they work on written component requirements for the National Board for Professional Teaching Standards. Candidates will have opportunities to integrate personal and professional growth through feedback, reflection and collaboration. This course will focus on the three writing styles: descriptive, analytical and reflective to express content knowledge and commitment to student learning.

This course will prepare students to:

- Evaluate and apply the results of scientifically based research to inform and improve student learning.
- Articulate the importance of keeping current in knowledge of the field of education.
- Demonstrate that ALL students are engaged in the learning process.
- Evaluate progression of student learning to inform teaching practices.

- Reflect on effective teaching practices.
- Demonstrate knowledge of qualitative and quantitative research, the history of teaching and best practices found within education and instruction.

Grading Scale

The grades earned for the course will be calculated using City University of Seattle's decimal grading system, found in the current University Catalog (<https://www.cityu.edu/catalog/>).

Grading rubrics with details on how each assignment will be graded are located under *Assignments* and/or in *My Grades* in the online course menu. Students should review the rubric for each assignment prior to completing their work in order to understand how it will be assessed.

Course Assignments and Grading

Component 1 (20% of grade)

Candidates will complete a review of released extended response (essay) questions and submit an essay stating which part of the prompt stood out as challenging and which was familiar. They

will connect the prompts to the various National Board standards and determine a process for studying the different sets of questions through identified resources. Candidates will practice a released prompt in a 30 minute timed session, reflecting on their review process and self-evaluate their readiness for their content.

Component 2 (20% of grade)

Candidates will analyze student work to identify strengths, areas of improvement needed and provide feedback to facilitate learning. They will submit student work samples along with a constructive feedback form to identify next steps of learning for each of the 1-2 students (depends on content of focus area) including lessons to build area of improvement success criteria. Candidates will submit a full rough draft of the component including the questions, receive peer and instructor review, and self-reflect on what is needed for completion of the component.

Component 3 (20% of grade)

Candidates will video tape 2+lessons to review with peers. They will transcribe the lessons, highlight and compare student and teacher engagement within the video lesson, and respond to National Board written response questions, Component specific, for a full draft analysis of the lesson for peer and instructor review. This term, two video drafts are required including questions for peer/instructor review.

Component 4 (20% of grade)

Candidates will focus on Assessment formats: formative and summative and connect to the student need and PLC work. They will submit a series of assessments for peer, instructor and self-review to determine student success criteria and a rough draft of Assessment section of component for peer and instructor review.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed

mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
