Course Description

This course examines public school law with an emphasis on the rights and responsibilities of students and teachers. Candidates analyze current issues and case studies specific to public education, special education and the education of recent immigrants for positive inclusion in a public school. Candidates learn professional boundaries, procedures, and resources to maintain a safe environment for teaching and learning.

Course Outcomes

This course will prepare students to:

- Apply knowledge of constitutional rights, federal regulations related to public schools, Washington State public school law, and examples of public school district policy in Washington to professional decisions.
- Analyze legal resources in order to support and positively include families recently immigrated or who have children with special needs.

- Demonstrate understanding of the laws affecting education of recent immigrants and students with special needs in order to positively include them in the learning community.
- Evaluate the requirements for identifying and reporting suspected issues of abuse and neglect.
- Analyze multiple perspectives on controversial topic related to public school law in order to build understanding of relationships with students and families.

Shared Agreements

Course Assignments and Grading

Legal Implications of Modern Technology (25% of Final Grade)

Candidates research a controversial technology issue with legal relevance in today's public schools. Candidates will produce a presentation that demonstrates: 1) research and court cases representing a range of perspectives on the issue, 2) rights and responsibilities of stakeholders (e.g. privacy, freedom of speech, confidentiality, etc.) 3) practical examination of teaching and classroom practices that intersect

with the issue, and 4) recommendations for teachers to consider with respect to the issue. The instructor will provide guidance on the means and mode of the presentation, whether the assignment may be performed individually or in groups, and final approval of topics.

Possible topics may include:

- Cyberbullying/Sexting
- Student's social media use
- Teacher's online presence
- Sharing pictures or data relating to students and students' work
- Students' use of classroom blogs
- Cell phone policies in classrooms
- Teacher's use of technology to communicate with parents and students
- Use of apps/programs for student motivation and feedback
- Student-developed web pages
- Copyright issues surrounding use of materials and pictures
- Boundaries surrounding teacher use of district technologies
- Plagiarism, plagiarism software, and group work on Cloud technologies
- Digital Divide
- Hybrid/virtual teaching
- Structural racism

HIB (Harassment/Intimidation/Bullying) + Child Abuse & Neglect + Suicide Prevention Action Plan (25% of Final Grade)

Candidates research all three areas of issues of HIB, abuse & neglect, and suicide prevention through news stories, court cases, laws, district policies, curricula, and school improvement plans. Candidates examine and reflect upon the teacher's role in promoting a learning environment and classroom culture to effectively address crises as they arise. Candidates will develop an action plan based on district protocols, best practices and information from OSPI that describes: 1) legal and perceived rights and responsibilities of stakeholders, including at least one lawsuit or court case 2) proactive classroom and school strategies, and 3) restorative practices for addressing issues as they arise.

Research Paper: Categorical Programs (30% of Final Grade)

Candidates choose a specific topic to research that lies within one of the large categorical programs in K-12 education. These programs include: 1) special education, 2) English Language Learners, 3) students being served under Section 504, and 4) gifted/talented programs. Candidates write a research paper about a topic within one categorical program that includes: 1) rights and responsibilities of stakeholders, 2) laws that inform categorical programs (e.g., IDEA, Section 504 of the Rehabilitation Act, etc.) 3) professional and collaborative procedures for inclusion of students in categorical programs, and 4) implications for candidates in their special or general education classrooms. The instructor will approve the selected topic within a categorical program for the paper.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
