## Course Description

In this course candidates examine the unique skills, abilities, and needs of individuals on the autism spectrum. The course emphasizes the variety of presentations along the spectrum, and examines strategies for supporting neurodivergent students in the K-12 education system. Candidates will gain an understanding of the history and sociopolitical context for supporting neurodivergent K-12 students, and candidates will be asked to critically evaluate current methods and strategies for cultural responsiveness and their ability to create empowering learning spaces for autistic students in the classroom. This course emphasizes listening to and amplifying the voices of those who are neurodivergent when evaluating systems and their effects on students' experiences in a classroom environment.

## Course Outcomes

This course will prepare students to:

- Understand the varied presentations, unique skills, abilities, and needs of neurodivergent students
- Develop an awareness of historical and sociopolitical contexts for current autism programs

- Evaluate current programs, methods, and strategies for cultural responsiveness and ability to create empowering learning spaces for neurodivergent students
- Create a personal growth plan for further learning about autism

## Grading Scale

## Course Assignments and Grading

### Historical Analysis and Reflection (25% of Final Grade)

Candidates investigate the historical and sociopolitical contexts of autism diagnosis and supports within the K-12 system. Analysis will include a discussion about how societal views have been shaped and changed over time about neurodivergence, and how these societal views have impacted the diagnosis, support, and programming for students on the autism spectrum. Candidates will reflect on what they've learned about the history of autism in the United States and how it relates to current practices in schools today. Candidates are asked to critically evaluate the methods seen today for cultural responsiveness and their ability to create empowering learning spaces for neurodivergent K-12 students.

## **Personal Experience Research or Interview(s) (25% of Final Grade)**

Candidates research autism and neurodivergence *solely using sources from the autistic community themselves*. Candidates reflect on how the varied personal experiences of autistic people in their own words/voices have impacted the candidate's views, personal biases, and/or approaches to working with neurodivergent students in their own classrooms.

## **Personal Growth Plan (30% of Final Grade)**

Candidates create personal growth plan specifically around continued learning about autism, neurodivergence, and ways to support, empower, and advocate for those students in the classroom setting. Candidates will provide specific new learnings and insights gained, deepened understandings, and at least 1 area in which they would like to deepen their learning and/or practice. Candidates will provide concrete steps they commit to taking in order to grow in their chosen area.

## **Participation, Engagement, and Essential Dispositions (20% of Final Grade)**

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person.

# **Course Policies**

### **Participation**

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
