Course Description

In this course candidates will explore the content requirements and mathematical practices outlined in the common core state standards. After developing their skills in decoding and unpacking math standards, candidates will choose a cluster of Common Core Learning Targets to use as the basis for backwards design lesson planning. A heavy focus will be on creating formative and summative assessments that are aligned with learning targets. From these assessments, candidates will create learning targets that are aligned and can be used for measuring and monitoring student growth throughout a lesson sequence.

This course will prepare students to:

- Design engaging learning experiences for students based on knowledge of student learning, content, community, equity, and curriculum goals

- Implement effective instructional strategies related to critical thinking and problem-solving skills
- Develop an integrated knowledge base about mathematics, learning and teaching that includes multiple perspectives and resources
- Engage in self exploration on how one learned mathematics and investigate beliefs about the ways children learn mathematics to develop a personal philosophy to support children's mathematical thinking and strategies used to learn mathematics

Course Assignments and Grading

Unpacking Math Standards: Targets and Assessments (80% of Final Grade)

Candidates will unpack a Common Core State Standard (CCSS) for math (content and math practices) and create aligned learning targets, formative assessments, and summative assessments for the selected standard. The assessments and learning targets that candidates create should show variety, differing levels of rigor, and characteristics of performance assessments.

Participation, Engagement, and Essential Dispositions (20% of Final Grade)

Candidates should participate and engage in all classwork, including required assignments, class discussions, activities, and instructor-determined assignments. Candidates should work to meet essential dispositions criteria not only in the field, but also in their coursework, whether online or in person

Course Policies

Participation will be graded based on engagement in class discussions and activities (both online and mixed modes). Online-only courses will be determined via active engagement in weekly discussion boards or other interactive opportunities provided by the instructor. Mixed mode courses will be determined based on presence in class and engagement with content and peers both within and outside of face-to-face class sessions.
