Course Description

Students identify how knowledge of the world of work, career opportunities, and information services is relevant to academic and social counselling in the public schools. They study educational and career decision-making, values, and information services as applied equitably to diverse groups. Students apply counselling theory and incorporate career planning and development into the counselling process.

Course Outcomes

This course will prepare students to:

- Explore the role of career counselling in K-12 education.
- Identify issues surrounding access, equity, and the impact of beliefs, values, and stereotypes on career counselling and career choices from both client and counsellor perspectives.
- Facilitate students and teachers in understanding the link between curriculum, instruction, and assessment to student effort, performance, and success beyond high school.
- Engage in reflective analysis and consider how to facilitate decision making process.

- Academic Competencies - Support students' academic competencies.

- Developmental considerations in career counselling

Research Paper: Best Practices in School-Based Career Counselling (40% of Final Grade)

For this assignment, students will use a research-informed approach to practice based on questions and parameters provided by the Instructor. Students should also integrate information from provincial curriculum standards for career and personal planning. Considerations regarding culture, diversity, and inclusive education must be addressed throughout where relevant.

Application of Theory (30% of Final Grade)

For this assignment, students will integrate and apply information and key points from their research to support the academic competencies of K-12 students. Assignment details will be provided by the Instructor and will include evidence of collaboration and supplementary materials to share with the cohort.
