Course Description

Students engage in research to study a problem in relation to school-based counselling. Students prepare a Capstone Project that explores a relevant research question, is based on current literature, and proposes practical recommendations for stakeholders or working practices within the school setting.

- Identify a research topic and develop a research question
- Analyze and synthesize scholarly literature to guide research/intervention planning
- Propose and develop an appropriate methodology, recommendations, or intervention for a real-world problem
- Author a graduate-level scholarly project
- Demonstrate competency in project management

Capstone Project (100% of Final Grade)

The capstone project allows a student to demonstrate mastery of both a specific topic and the relation of this topic to the role of the school counsellor, teacher, administrator, and the school community. The capstone project should also demonstrate the student's writing, analytic, and interpretive skills. It combines various kinds of practical experience (e.g., as a school counsellor) and current literature (e.g., what is known about the chosen topic) with analytical and interpretive writing in the form of a large essay.

Students formulate an individual timeline to complete the research project, including planning, reviewing literature, and writing all sections of the project. Students will have a Capstone orientation/tutorial and work continuously in consultation with their Capstone advisor. Students are expected to connect with their faculty advisors in a proactive manner through regular communication.

Students format their research papers using a comprehensive reporting standard. The Capstone Project options will vary depending upon the option chosen, but it will include relevant inquiry-informed recommendations and/or intervention or school-based project to address a specific school-counselling-related need. APA style and formatting must be used throughout the paper.
