Course Description

The course purpose is to introduce students to information literacy and the processes basic to educational research. Students use online technology to access scholarly journals and a variety of professional online sources for developing their research focus; they evaluate journal articles and prepare a bibliography to explore the topic of their research. Students apply critical reading and analysis skills in reviewing scholarly journals and other resources. They develop understanding of information technology and its use in research and in practical decision-making as an educational leader.

Summary and Evaluation of a Research Article (30% of Final Grade)

Students will participate in the critical evaluation of research articles. Students will use a research topic and identify a peer-reviewed research article relevant for the research topic. They will summarize and evaluate the study. The activity of reviewing an article is an essential part of developing the tools and skills that are imperative to the research process.

Students will summarize the article, include the key themes/points, provide an evaluation and reflective thoughts about the relevance, significance, and implications of the article for the research focus.

Cultivating a Research Focus (50% of Final Grade)

In this assignment, students begin to cultivate the research focus that could potentially be used in their future capstone research. They will articulate a research focus, identify relevant sources, and evaluate one of the sources from the list.

Students will provide a clear and comprehensive discussion of their research focus. They will identify relevant sources to explore their research focus and create a list (bibliography) of relevant sources in APA.

For this assignment, students will choose one of the sources from the list and evaluate it. In this paper, students will discuss the article: summarize the article clearly and provide a critical evaluation of the article and its key themes/points. Students will discuss the relevance, significance, and implications of the source, and make connections to the research

focus. Where possible, students can include comparisons and contrasts between the source and the other sources, for example, noting authors who have similar arguments and those that diverge; they can also identify limitations, weaknesses, and/or gaps and their implications for the research focus.

This critical evaluation may serve as the starting point for how students begin to evaluate and assess literature in preparation for writing their future capstone projects.
